Abstract (en)
[origin: EP2487876A1] A vehicle-mounted device is provided which can operate in combination with the existing profiles when the vehicle-mounted device and a portable device are connected to each other using Bluetooth (registered trademark) and transmit and receive an E-mail using MAP and a vehicle-mounted device is also provided which is safe and convenient for a user when the existing handsfree call function or the existing phone book transmitting function are performed in a state where an E-mail transmitting and receiving function can be performed and operate in combination (multi-profile operation). The vehicle-mounted device includes: a phone book acquiring section for acquiring the phone book data of the portable device via a communication section; a manipulation section for rejecting an arrival of a call at the call section; a specification section for specifying a mail address of the opposite party from which the arrival of a call is rejected by the manipulation section with reference to the phone book data; and a call-rejected party mail-reception notification suppressing section for suppressing the notification of reception of an E-mail from the mail address specified by the specification section to the vehicle-mounted device.
