Abstract (en)  
[origin: WO2011048013A1] The invention relates to a grinding machine for grinding workpieces (20, 22, 48, 60), in particular for simultaneously grinding two closely adjacent workpieces (48). Said grinding machine comprises at least two first grinding spindles (26, 26') and at least two second grinding spindles (28, 28') which respectively comprise a grinding disk receiving element (37) and are pivotably mounted on the spindle block (30) on one of the first grinding spindles (26, 26'), by means of a support (40) such that they can be pivoted about the rotational axis (46) of the respective first grinding spindle (26, 26').
