Abstract (en)
[origin: CA2774752A1] The invention relates to a catching device (5) and a catching receptacle (3) cooperating therewith, to be attached laterally to a weapon station (1), for example. In a preferred embodiment, the catching receptacle (3) is arranged separately and either adjacent to or behind the weapon station (1). After firing, the empty shell and/or the belt links and/or the connector elements (8) are guided toward the lateral catching device and from there into the catching receptacle (3). Due to the special design of the catching device, the guidance is preferably done by sliding the parts (8) along the rear wall (5.3) of the device (5).
