[origin: WO2011054579A1] The invention relates to a damping device (99) for damping vibrations, in particular in handheld machine tools, having a spring element (100, 101, 102, 103, 104). According to the invention, the spring element (100, 101, 102, 103, 104) has at least two regions (130, 140, 230, 240, 330, 340, 430, 440) which differ in at least one element parameter and/or one material parameter.
