Abstract (en)
The present invention relates to a sporting shoe with a sole (13) having a tip (26) and a heel (28), a longitudinal axis (L), a border line (20) with an external part (11) and an internal part (12) divided by the tip (26) and the heel (28), wherein the sole (13) is subdivided into a forefoot section (30), a mid foot section (32) and a rear foot section (34), the sole comprising a number of studs (14).
