Abstract (en)

[origin: CA2790618A1] The invention relates to a device and a method for extracting a carbonaceous substance, especially bitumen or extra-heavy oil, from a reservoir (6). Thermal energy can be supplied to the reservoir (6) to reduce the viscosity of the substance. For this purpose, at least one conductor loop (10, 11) is provided as an electric/electromagnetic heater to be inductively supplied with power, a conductor (10) of the conductor loop (10, 11) being surrounded by a liquid-carrying conduit (12) in at least one section.
