[origin: WO2011076412A1] The invention relates to pharmaceutical formulations, preferably in the form of an oral administration, for treating chronic hepatitis B viral infections, containing micronized entecavir, and to a method for the production thereof. The invention further relates to intermediates, containing micronized entecavir, in which the D50 value of the particle size distribution is smaller than 50 µm, and to a method for the production thereof.
