Abstract (en)

The present invention provides a method for transmitting an acknowledgement/negative acknowledgement message. A terminal performs a bundling operation on ACK/NACK message of various received downlink component carriers, obtains the bundled ACK/NACK response message and transmits it on a physical uplink control channel appointed by a base station and the terminal. The present invention realizes transmission of the ACK/NACK response message in a scenario of carrier aggregation.
