Abstract (en)
A smoking article (10), comprising a rod of smokeable material (11); and a first sheet material (13) comprising at least one diluent, wherein said diluent is present in an amount effective to dilute emissions from the rod of smokeable material during combustion; and a second sheet material (12) which does not contain diluent, wherein said second sheet material (12) is wrapped around the circumference of the rod of smokeable material (11) and extends along the entire length of the rod of smokeable material (11).
