Abstract (en)

The high-heeled shoe (1) has a sole structure that is provided with a heel (10) having a height of 4cm. The heel is provided with a damping device (20). The damping device is provided with a damping element (21). The damping element is freely deformable in a direction perpendicular to the longitudinal axis of the heel. The cross section of damping element is variable along the longitudinal axis of the heel. The ratio of largest cross section to smallest cross section of damping element is 1.3 or 1.5-4.

Abstract (de)

High-Heel-Schuh (1) mit einer Sohle (6-9) und einem daran vorgesehenen Absatz (2,3) mit einer Höhe von mindestens 4 cm, wobei der Absatz mit einer Dämpfungseinrichtung (20) versehen ist. Die Dämpfungseinrichtung weist mindestens ein Dämpfungselement (21) auf. Das Dämpfungselement hat entlang der Absatzlängsachse unterschiedliche dämpfend wirkende Querschnitte und/oder ist zumindest in einer Richtung senkrecht zur Absatzlängsachse frei verformbar.
