Abstract (en)

The clamping device (100) comprises clamping jaws (7), which take a defined clamping distance in a clamping position, in which a workpiece is held. An adjusting device is provided for presetting different defined clamping distances depending on the measurements of the workpiece that is clamped. The adjusting device is incorporated in a guide housing (8), in which a guide element is guided movable on a defined adjustment path.

Die vorliegende Erfindung betrifft eine Spannvorrichtung (100) mit Spannbacken (7), die in einer Spannstellung einen definierten Spannabstand (S) einnehmen, in dem ein Werkstück (44) gehalten ist. Erfindungsgemäß ist vorgesehen, dass eine Justiervorrichtung (29, 17, 19) zum Voreinstellen verschiedener definierter Spannabstände (S) in Abhängigkeit von den Abmessungen des zu spannenden Werkstücks (44) vorgesehen ist.
