[origin: WO2011113427A1] The invention relates to a packaging for objects that have a portion of liquid, comprising a container (1) composed of a liquid-impermeable material for receiving the object (9) and a dimensionally stable hollow body (10, 13, 15), which has at least one opening (12, 14, 16) and is arranged in the container (1) and receives the liquid that escapes an object (9) arranged in the container (1).
