[origin: WO2011124620A1] The invention relates to an applicator (1) for applying a product to the eyelashes, comprising a core (7) which comprises two branches twisted together over at least a portion of the length thereof; the core consecutively clamps onto a first applicator member (5) made of a single piece and having a plurality of applicator elements, and a second applicator member (6) comprising a plurality of bristles.
