[origin: CA2795958A1] The invention relates to a vehicle, in particular a military combat vehicle, comprising a hull (2) that accommodates the vehicle crew, a turret mount (3) arranged above the hull (2) for accommodating a primary weapon (4), an auxiliary mount for accommodating a secondary weapon (6), and a panoramic viewing device (7) for observing the vehicle surroundings, wherein the panoramic viewing device is arranged on the auxiliary mount and/or the auxilliary mount is arranged above the turret mount at a hull-mounted fastening point.
