Abstract (en)

[origin: WO2011138425A1] The present invention relates to a method for the catalytic removal of sulphur dioxide and carbon dioxide from exhaust gases in a reactor charged with an activated carbon catalyst, wherein the method comprises the following steps: ° saturation of the activated carbon with SO₂, ° saturation or partial saturation of the exhaust gases with water, ° introduction of the exhaust gases into the reactor, ° catalytic conversion of the SO₂ to H₂SO₄ and in parallel thereto, the catalytic conversion in the presence of the same catalyst of CO₂ to C and O₂ and also to sulphur-carbon compounds. ° Washing out the catalyst and discharging the H₂SO₄ as liquid and the C as solid and/or bound to sulphur compounds.
