Abstract (en)

The assembly (1) has an adjusting unit to adjust a longitudinal play between the assembly and a plate (10)/bridge (11) carrying the assembly. The adjusting unit is formed by a wedging/stroke limiting unit to wedge or limit stroke of a drum (3) and/or a cover (7) with respect to the plate/the bridge to constitute a chamber enclosing a barrel spring (2) or by a guiding unit to guide pivoting of the drum or/and the cover into the plate and/or the bridge to constitute the chamber. The adjusting unit is formed by the limiting and guiding units to limit the play in direction of swivel axis (D). An independent claim is also included for a clockwork movement.

Abstract (fr)

Ensemble bâillet (1) d'horlogerie, comportant un ressort moteur (2) monté entre un tambour (3) de bâillet, et une surface de réception (5) que comporte une bonde (4) coaxiale audit tambour (3) autour d'un axe de pivotement (D). Il comporte des moyens d'ajustement de l'ébat longitudinal (6) entre ledit ensemble bâillet (1) et une platine (10) porteuse dudit ensemble (1), constitués ou par des moyens de calage, par rapport à ladite platine (10) dudit tambour (3) ou/et d'un couvercle (7) fixé sur ledit tambour (3) pour enfermer ledit ressort (2), ou par des moyens de guidage en pivotement ,directement dans ladite platine (10), dudit tambour (3) ou/et dudit couvercle (7), ou par la combinaison desdits moyens de calage et desdits moyens de guidage en pivotement.
