[origin: WO2011144209A2] The invention relates to a weapon system, comprising a weapon (2) for firing ammunition bodies, wherein a scanner that examines the structure of an ammunition body is provided for the weapon. The invention further relates to a method for firing ammunition bodies (3) by means of a weapon (2), wherein the structure of the ammunition body (3) is examined by means of a scanner (6) before the ammunition body is fired, and to a method for detecting ammunition bodies, wherein the structure of the ammunition body (3) is examined by means of a scanner (6).
