Abstract (en)

A method for preparing a flexographic printing master wherein an optional floor (600), an optional mesa relief (700) and an image relief (800) are applied in this order on a flexographic printing support (1000) by depositing a plurality of layers of a curable fluid on top of each other characterized in that at least one layer of a curable fluid is deposited by aerosol jet printing
