Abstract (en)
The pallet (100) has object receiving units (112) arranged at a base body (102) to receive objects. The receiving units are arranged in receiving planes, which are different from each other. The receiving units comprise support regions (114), which are concentrically arranged with respect to each other and exhibit mutually different dimensions. The receiving units comprise circular or octagonal security areas (116) i.e. projections, for securing the objects arranged in the receiving units against slipping. The base body is partially or completely formed of plastic material.

Um eine Lager- und Transportpalette (100) zum Aufnehmen von zu lagernden und/oder zu transportierenden Objekten, umfassend einen Grundkörper (102) und mindestens eine an dem Grundkörper angeordnete Objektaufnahme (112) zur Aufnahme mindestens eines Objekts, zu schaffen, welche eine sichere Aufnahme von Objekten unterschiedlicher Art und/oder Größe ermöglicht, wird vorgeschlagen, dass die Lager- und Transportpalette mindestens zwei Objektaufnahmen (112) umfasst, welche in mindestens zwei voneinander verschiedenen Aufnahmeebenen (126) angeordnet sind.
