Abstract (en)
[origin: WO2012001042A1] The invention relates to a boot (10), in particular a ski boot or snow board boot, having at least two fixing devices, in particular lacing systems (50a, 50b, 50c', 50c"), and a boot body (20) with - an upper zone (2.2, 3) for at least partially enclosing a wearer's fibula and tibia; - a lower zone (2.1, 2) for at least partially enclosing the front of the wearer's foot; and a central zone (1), which is located between the upper zone (2.2, 3) and the lower zone (2.1, 2) and encloses the wearer's heel and ankle, wherein the central zone (1) can be fixed, in particular laced by a lacing system (50a), independently of the upper zone (2.2, 3) and independently of the lower zone (2.1, 2).
