[origin: CA2804652A1] The invention relates to a bandage for a knee joint, comprising an elastic textile hose, a ring- or strap-shaped elastic profiled insert, which is arranged in or on the textile hose for encompassing at least the lateral (fibula-side) section of the patella of the knee joint, and at least one flexible tension band, which extends over the knee joint substantially in the longitudinal direction of the bandage and which is not extendible.
