[origin: WO2012013899A1] The invention relates to an assembly for protecting an item against theft, characterised in that it includes a device (10) for marking the item with a view to identifying same, the device including an area (16) for displaying information, a storage medium (26) in which data to be displayed is stored, a means (22, 24) for selecting data from the storage medium (26) to be displayed in the display area (16), wherein the protection assembly includes a means (14) for attaching said assembly to the item to be protected or to the packaging thereof.
