Abstract (en)

[origin: WO2012022788A1] A pull-out guide in particular for domestic appliances, having a guide rail (4) and at least one additional rail (2, 3), which are mounted such that they can be displaced relative to one another via rolling-contact bodies (6), accommodated by a cage (5), and have at least one stop, in order to limit the displacement distance of the additional rail(s) (2, 3), wherein the at least one stop is designed as a crosspiece (21, 32, 41) which is made on the guide rail (4), or on at least one of the additional rails (2, 3), and projects into the displacement path of the cage (5), or of an outer rolling-contact body (6), as seen in the displacement direction (x), as far as the axis of rotation, or at least as far as half the radius of the rolling-contact body (6).
