Abstract (en)  
[origin: WO2012022469A1] In the case of an identification mat for identifying electrical components having a plurality of identification units (10), wherein an identification unit (10) has a crossbar (12) and a plurality of identification plates (14) integrally moulded on the crossbar (12), wherein the identification units (10) are connected to one another by means of a frame (16), wherein the frame (16) is provided with guidance means (18a, 18b) for guiding the identification mat in a printer, the aim to be achieved is to provide a solution which allows identification units (10) to be provided which can be labelled or printed essentially using all commercially available printing methods, particularly using a thermal transfer printing method and/or an inkjet printing method. This is achieved by virtue of the identification mat being produced from an amorphous plastic.
