[origin: US2012077719A1] The invention is directed to oil soluble additive compositions, lubricating oil compositions, and additive concentrates. The oil soluble additive composition comprises a salt or complex of (i) a molybdenum component which comprises a molybdenum oxide, sulfide, or oxysulfide of the general formula MoO_xS_y wherein x#0, y#0, and 12#(x+y)#2; and (ii) an imide wherein said imide comprises the reaction product of at least one dicarboxylic acid component having from about 8 to about 22 carbon atoms, and at least one nitrogen compound selected from ammonia and a polyamine.
