Abstract (en)

[origin: EP2623305A1] In a defective product removing device for a box macking machine and a box macking machine, a manufacturing line of a cardboard box (B) is provided with a quality determining device (101) that determines a quality of a conveyed cardboard sheet (S) by performing a predetermined inspection thereon, a defective product removing portion (51) that removes the cardboard sheet (S) of which a surface is subjected to creasing processing and slotting from the manufacturing line, and a sorting device (102) that operates the defective product removing portion (51) with respect to the cardboard sheet (S) determined as a defective product by the quality determining device (101), thereby appropriately removing the sheet material as the defective product and improving the working efficiency.
