[origin: WO2012052685A1] The invention relates to a method which involves a kit of two cosmetic, pharmaceutical, veterinary and food compositions, designed for slimming or for preventing and/or repairing inflammatory mechanisms, one of the compositions including at least one sirtuin activator and at least one HSP activator, and the other composition including at least one sirtuin inhibitor and at least one HSP inhibitor. Said compositions are intended to be delivered in a chronomodulated pattern. Said compositions are particularly effective in combination with one another for controlling adipose, fibrous or aqueous cellulite, cell ageing and inflammatory processes.
