Abstract (en)

[origin: EP2630904A1] The household appliance (1) has a housing (2), a screen (3) and a control unit (4) for operating the household appliance, where a memory is provided with a program for operating the household appliance. A communication device is provided with a unit for data transmission and for providing an operative connection with a mobile device (5) having a control- and display unit (6). The household appliance is arranged to receive and enable a program or parameter setting in the control unit for execution of the mobile device. The communication device is designed for wireless data transmission. An independent claim is included for a mobile device for use with a control- and display unit.
