[origin: WO2012055670A1] The invention relates to a replaceable tool (10) for an electric machine tool (100), which effects a high-frequency working motion of the tool (10), comprising a tool body (12) having a first end (14), which is designed for coupling to the electric machine tool (100), and a second end (16), which is designed for receiving a functional element (20), wherein the tool body (12) is designed at least as a longitudinal section (18) of a coupling element (150) provided for transmitting the high-frequency vibrations to at least the functional element (20).
