## Abstract (en)

Provided is a packaged particulate detergent composition, wherein the composition is of large particles with good flow characteristics. The composition comprises surfactant selected from anionic and non-ionic surfactant, citric acid and sodium salts thereof, a phosphonate sequestrant, an inorganic salt selected from sodium carbonate and sodium sulphate, optionally a soil removal polymer and peroxide; the inorganic salt is present on the detergent particles as a coating and the surfactant as a core. The pH of a 1 wt % solution of the detergent composition is in the range from 7.2 to 10. The preferred shape of the coated particles is an oblate spheroid. A process for washing laundry is also claimed.
