[origin: CA2817803A1] The invention relates to an expandable composition containing a polymer selected from among the group consisting of polyvinyl chloride, polyvinylidene chloride, polyvinyl butyrate, polyalkyl (meth)acrylate, and copolymers thereof, an expanding agent and/or foam stabilizer, and di-2-ethylhexyl terephthalate as a plasticizer. The invention further relates to expanded molded articles and the use of the expandable composition for floor coverings, wallpapers, or synthetic leather.
