[origin: WO2012097790A1] Fragmentable projectile casing for an explosive projectile (7), having an uneven wall thickness (W) and having predetermined breaking points (2) distributed over the projectile casing (1) for the shaping of fragments, wherein the predetermined breaking points (2) are spaced irregularly apart from one another to achieve uniform fragments; fragmentable projectile casing for an explosive projectile (7), having predetermined breaking points (2) distributed over the projectile casing (1) for the shaping of fragments, wherein the predetermined breaking points (7) are formed as changes in the material structure that run in the longitudinal direction (L) and extend through the entire wall thickness (W); method for handling a fragmentable projectile casing (1) for an explosive projectile (7), having an uneven wall thickness (W) and having predetermined breaking points (2) distributed over the projectile casing (1) for the shaping of fragments, wherein the predetermined breaking points (2) are spaced irregularly apart from one another to achieve uniform fragments.
