[origin: EP2657126A2] The submarine has an ejection tube (2), in which a closed expansion body (12) is arranged in the ejection direction in the front of an object that is mounted in the ejection tube. The ejection tube is a weapon tube for ejecting a weapon. The expansion body is partially formed from a flexible material. The expansion body is a bellows. The expansion body has a rigidly formed section which forms a contact area with the object mounting in the ejection tube.
