[origin: US2012233532A1] An apparatus for a vector-based form field document includes a reference module referencing document content for a vector-based document and referencing form field information corresponding to the document content. A loading module loads the document content in a vector-based document viewer. An insertion module inserts one or more form fields onto the document content in the viewer. The one or more form fields are inserted based on the form field information. Each form field includes a field for user input.
