Abstract (en)
The case has a tubular envelope with articulated panels (2-5) equipped with two ends, where one of the ends is opened. A closing panel (13) is articulated on the articulated panel. A cutting (38) is arranged in a locking flap (17) to form a locking strip (36) that is mounted in a swiveling manner on the locking flap around two fastener zones (37) of less resistance. The locking strip is intercalated by its swiveling. The locking strip is detached partially or completely from the locking flap by its blocking on a blocking edge (33) of a folding shutter (30). An independent claim is also included for a precut blank.

Abstract (fr)
L'invention concerne un étui de conditionnement à témoin d'ouverture, obtenu à partir d'un flan (1) prédécoupé et monté, par pliage, comportant des moyens de verrouillage. Ces moyens de verrouillage comportent : - un volet de fermeture rabattable (30) articulé sur le panneau (4) de l'enveloppe situé en vis-à-vis du panneau (2) de l'enveloppe équipé du panneau de fermeture (13), le volet de fermeture rabattable (30) possédant un bord de blocage (33), - une languette de verrouillage (36) montée pivotante sur le rabat de verrouillage (17), autour de deux zones d'attache (37) de moindre résistance, la languette de verrouillage (36) étant destinée à venir s'intercaler en partie, en position de fermeture du panneau de fermeture (13), entre le volet de fermeture (30) et le panneau (2) de l'enveloppe.
