Abstract (en)
[origin: WO2012120290A2] The present invention relates to a topical skin care formulation comprising a) β -(1,3/1,6)- glucan and b) a protein-containing plant extract, wherein said plant is of the family Fagaceae; or c) a protein-containing plant extract, wherein said plant is of the genus Vigna. The present invention also relates to a topical skin care formulation comprising β -(1,3/1,6)-glucan and an oxidoreductase. The present invention also relates to an oral composition comprising (i) borage seed oil and astaxanthin; or (ii) vitamin C, collagen hydrolysate, chondroitin sulphate and glucosamine, and also to kits comprising such oral compositions and optionally such topical skin care formulations. The present invention also relates to cosmetic skin treatment method in which these oral compositions and/or topical formulations are used.
