Abstract (en)

[origin: WO2012143517A1] The invention relates to a device and a method for printing the surface of a flat or cylindrical printing-image store (1, 1'), wherein the device consists of an arrangement of closely adjacent cells (3), having a printing-image store (1, 1') which is assigned displaceably to a frame (13), having a coating device (16) which is assigned to the frame (13) and by way of which a protective layer and/or a primer (5) can be applied to the surface of the printing-image store (1, 1'), having a printing device (17) which is assigned to the frame (13) and by way of which ink can be introduced into the cells (3) or can be applied to the cylindrical printing material at selected points of the surface of the printing-image store (1, 1') by means of an inkjet print head, having a drying device (18) which is assigned to the frame (13) and by way of which the protective layer and/or the primer (5) which is applied to the surface of the printing-image store (1, 1') or the ink (6) which is introduced into the cells (3) or is applied to the cylindrical printing material can be dried, and having a positioning device (28 to 31), in order to move the carrier (12) between the coating device (16), the drying device (18) and the printing device (17) and to position it there in each case in a processing position.
