Abstract (en)

A game piece (20) for a fighting game is movable on a surface when an external force is applied to the game piece (20), and includes a mount (30), and a figurative body (70) provided on the mount (30) and having attack means (60) for overturning a game piece (20) of an opponent. The mount (30) includes a front portion that protrudes to the front with respect to a support position on the mount (30) for the figurative body (70), a front side portion that protrudes to at least one of the left and right from the front portion, and side portions, at least a portion of one of the side portions provided with the protruding front side portion being located at a position close to the support position with respect to a protruding end of the front side portion.
