Abstract (en)

[origin: WO2012163987A1] The invention relates to a method for managing parking passes via a system for managing parking passes, including at least one device for dispensing a parking pass, and a server for centralizing the parking passes, the centralization server being connected to the or each dispensing device via a data link, said method including the following steps: a user inputting an identification code to the dispensing device (12); the dispensing device outputting (150) a parking pass to the user; and recording (160) the parking pass in a file stored in a memory of the centralization server. The method further includes modifying a subsequent parking pass, for each identification code, depending on the previously output parking passes that were recorded in the recording file, each modification being associated with a parking area and a time interval.
