Abstract (en)

The device (10) has a mouthpiece (12) inserted between lips and teeth of a user. The mouthpiece is formed as a vibrator that produces active, mechanical vibrations. The mouthpiece includes a vibration unit i.e. vibration motor, which is radially protruded off from a front face (14) of the mouthpiece that rests against a lip inner side. Frequency of the vibration unit lies between 5 and 20 hertz. The vibration unit is coupled with the mouthpiece over coupling elements e.g. wire spirals and wire meshes. The device is made of silicone.

Vorrichtung (46) zur Aktivierung der Mund- und/oder Lippenmuskulatur, umfassend ein zwischen die Lippen und die Zähne eines Benutzers einsetzbares Mundstück (48). Um die Benutzung der Vorrichtung zu vereinfachen und deren Wirkung zu verbessern, ist vorgesehen, dass das Mundstück (48) als ein aktiver, mechanische Vibrationen erzeugender Vibrator (56) ausgebildet ist.
