Abstract (en)
[origin: WO2012176137A1] The invention relates to a binding support (10) that can be used in bookbinding, comprising: - a supporting surface (14) suitable for supporting a bundle of sheets; - finger-type rods (11) which point from the edge of the supporting surface (14) essentially in the perpendicular direction relative to the supporting surface (14) and against which the rear edge (152) of the bundle of sheets (49) that is to be placed on the supporting surface (14) can be aligned, and which are configured in such a manner that a binding gap (16) remains in each case between the finger-type rods (11); and - at least one limiter located below the finger-type rods (11) and the supporting surface (14), which is retracted with respect to the inner edge of the binding gaps (16). The patent application likewise contains independent claims for the method and the device arrangement.
