Abstract (en)  
The present invention relates to a laundry washing machine (1) for household use comprising a cabinet (2) and a suspension system that keeps an oscillating assembly (3) suspended inside the cabinet (2), said suspension system comprising at least one shock-absorbing element (6), which is coupled to the oscillating assembly (3) through an upper mount (7S) comprising: - a first end portion (61) of the shock-absorbing element (6), - at least one fin (30) of the oscillating assembly (3), - a pin (10) adapted to be inserted into a hole (30F) of said at least one fin (30) and into a bushing (61B) of said first end portion (61) of the shock-absorbing element (6). The invention is characterized in that said pin (10) is made of metallic material, in particular sheet steel.
