[origin: WO2013021330A1] An electrical household appliance (1) for treating textile articles or garments or dishes or food products, comprising :
- data storage means (2) in turn comprising a plurality of portions, including a first PORTION (21) and a second portion (22), said second portion (22) having prememorized in it a program for treating textile articles or garments or dishes or food products; acquisition means (3) of a program for treating textile articles or garments or food products; - a control unit (4) which causes the program captured by the acquisition means (3) to be memorized in the first portion (21); -a user interface (5) for selecting at least the program memorized in the first portion (21), the interface (5) being able to select the programs memorized in the plurality of portions (21, 22) of the storage means (2); said first portion (21) being rewritable and memorizing information for an indefinite length of time until the information is overwritten or deleted.
