Abstract (en)
[origin: WO2013023737A2] The invention relates to a sliding door system having a frame (1, 1', 2, 2'), which receives one or more sliding doors that, mounted in or on the frame (1, 1', 2, 2'), can be moved horizontally along the frame (1, 1', 2, 2'), wherein the sliding doors are constructed as folding door elements (11, 12, 13), in which two door elements (14, 15) are connected to each other in a hinged manner by means of a joint arrangement running vertically centrally between the door elements, wherein the joint arrangement can be pivoted out of the plane of the frame, such that the two door elements (14, 15) can be opened at right angles to the plane of the frame and lie flat on each other in an open position.
