Abstract (en)

The invention relates to a device for offering at least one of a plurality of cigarettes (5) contained in a package, comprising: an inner liner (1; 101) designed to cover at least a part of the plurality of cigarettes (5), the inner liner (1; 101) comprises a pull means (15; 115) for moving at least one cigarette (25) of the plurality of cigarettes (5) into an offering position (31). The pull means (15; 115) is designed to be actuated by a removal of the inner liner (1; 101). The invention further relates to a package containing a plurality of cigarettes.
