Abstract (en)

[origin: WO2013026734A1] The invention relates to a domestic appliance having a touch-sensitive operating and display device (1, 1') which has a display unit (11, 11') for displaying operating information and a light-permeable carrier part (3, 4'), on which at least one capacitive sensor electrode (13, 14, 13', 14') is arranged as part of a touch capacitance, which at least one capacitive sensor electrode (13, 14, 13', 14') is arranged so as to overlap with the display unit (11, 11') and so as to overlap with a touch-sensitive actuating surface (10, 10') of the operating and display device (1, 1'), wherein the at least one sensor electrode (13, 14, 13', 14') is formed from a transparent and electrically conductive paint and/or adhesive which contains carbon nanotubes.
