Abstract (en)
[origin: EP2754801A2] The counter case (1) or mortise dead lock, has an upper rod connection (10) for connecting an upper rod and a lower rod connection (11) for connecting a lower rod. A lock mechanism is configured such that only the upper rod connection extends for locking the rods, while the lower rod connection is locked in a retracted position through a locking device. The upper rod connection unlocks the locking device after reaching a predetermined extension position.
