Abstract (en)

[origin: WO2013037463A1] In the manufacture of packages from or with a blank (10) of thin cardboard, a material web (34) that is prepared in terms of printing according to the appearance of the packages is processed. Firstly, the blanks (10) are separated from the web (34) taking the printing into account. Subsequently, the blanks (10) are provided with necessary applications (embossing, punching) in the region of an application assembly (37) and then delivered to a packing unit.
