Abstract (en)

[origin: EP2775240A2] The device (1) has a through side wall (3) which is provided with a working space (4). The side wall is arranged with several nozzles (6) for the energization of the vehicle chassis (2) with tempered air. The nozzles are arranged in parallel to the direction of movement of the vehicle chassis. The lower row (8) of the side wall is provided with a window opening (10), while upper row (9) is provided with floor structure (12). The total number of nozzles in the upper rows of the side wall is less than the number of nozzles in the lower rows of the side wall.
