Abstract (en)
[origin: WO2013087226A1] The invention relates to a film product (10) for packaging products, particularly liquids (200), pasty and/or pourable materials, in sealed film packages (100), said film product having at least two film layers (20a, 20b). The film layer (20a) directed outwards is thermally stable and the film layer (20b) directed inwards is sealable, and both film layers (20a, 20b) are produced by a water-cooled blow coextrusion process.
